In case of using the cross border pipelines listed under subpoints aaf) and aag) of subpoint aa) of point a) of section (1) of § 2, the Network Users shall pay the exit capacity fee related to subpoint aaa) of subpoint of aa) of point a) of section (1) of § 2, prescribed in point II. of Annex No 2. as well.

In case of using the cross border pipeline according to subpoint aan) of subpoint aa) of point a) of section (1) of § 2 and using transmission system within territory of Hungary jointly, the Network Users shall pay import capacity fee related to subpoint aan) of subpoint aa) of point a) of section (1) of § 2, specified in point II. of Annex No 2.: 19,87 HUF/(MJ/d)/y and the general fee to be paid for use of the Romanian interconnector: 229,50 HUF/MJ(h)/y = 9,56 HUF/MJ(d)/y. ***According to the section (3), 10. §. of the 1/2013. (VII.11) MEKH decree, in case of capacity booking in reverse of physical flow (backhaul), the payable fee shall be calculated in the following way: in case of Exit points defined in subpoints aaa) and aca) of subpoint aa) of point a) of the section (1), 2. §, the payable fee shall be calculated on the basis of Entry domestic production fee according to aae) subpoint of aa) subpoint of a) point of the section (1), 2. §. In case of Entry points defined in aac), aad), aae) and acb) subpoints of aa) subpoint of a) point of the section (1), 2. §, the payable fee is calculated on the basis of the fee defined for Exit points in compliance with aaa) subpoint of aa) subpoint of a) point of the section (1), 2. §. In case of cross border exit points defined in aaf) and aag) subpoints of aa) subpoint of a) point of the section (1), 2. §., the payable fee shall be calculated on the basis of the fee defined for Exit cross border point according to aaf) or aag) points. In case of access the cross border pipeline in reverse of physical flow, according to aaf) and aag) subpoints of aa) of point a) of the section (1), 2. §., the System User shall pay also capacity backhaul fee calculated on the basis of Exit fee according to aaa) sub point of aa) subpoint of a) point of the section (1) 2. §.
