

## Daily gas transmission capacity offer of Magyar Gáz Tranzit Ltd. the commercial period from 1<sup>st</sup> of September 2015 until 30<sup>th</sup> of September 2015

We kindly inform you, that Magyar Gáz Tranzit Ltd. (hereinafter referred to as MGT) has published on its website ([www.gaztranzit.hu](http://www.gaztranzit.hu)) its daily gas transmission capacities available to book for the period commencing from 1<sup>st</sup> of September 2015 for gas days for the Balassagyarmat SK>HU cross-border interconnection point, as an entry point and for the Balassagyarmat HU>SK cross-border interconnection point, as an exit point according to the following:

### **Tariff:**

The transmission fees are calculated in accordance with the current MEKH Decree on gas network access fees, the rules of using incentives for improving service quality by the network operator by means of network access pricing, on applicable network fees depending on service quality, and on the conditions of applying network access fees, 1/2013.(VII.11.), Tariff Decree and its amendments.

### **Request and Allocation mechanism:**

1. The Requestor shall undertake to contract with MGT according to the following:

- Daily Interruptible Framework Contract – signed no later than 5<sup>th</sup> working days before the first requested gas day
- Capacity Booking and Information Technology Platform Agreement (MGT KLIP FM) – signed no later than 5<sup>th</sup> working days before the first requested gas day

The above mentioned contracts will come into effect as it will be signed by System User and MGT and MGT will send it to the System User on the day of signature via e-mail.

2. Capacity Requests shall be submitted on the MGT's Capacity Booking and Information Technology Platform (MGT KLIP) according to the 8.6.1.3 point of the effective Grid Code. The capacities will be allocated according to the effective Grid Code
3. The Requestor or its contractual partner shall undertake to conclude the required transmission contract with the adjacent System Operators.
4. According to the Government Decree 19/2009 (I. 30.) implementing the Act XL of 2008 on Gas Supply (GET), no financial obligation and no capacity booking is required at Vecsés connection point, but requestors must have KFSZRI contract with FGSZ for transition to the adjacent FGSZ system.
5. MGT shall require financial guarantee according to the General Terms and Conditions and Business Rules, which shall be the precondition for concluding the contract.
6. Requestor shall be submitted its shipper pair by the adjacent System Operators no later than 5<sup>th</sup> working days before the first requested gas day. In default of it MGT is not able to accept the nominations.
7. MGT will provide the capacities according to the confirmed quantity on its Capacity Booking and Information Technology Platform (MGT KLIP).
