

Interruptible daily gas transmission capacity offer of Magyar Gáz Tranzit Ltd. during the test period from 1st of April to 30th of April 2015

We kindly inform you, that Magyar Gáz Tranzit Ltd. (hereinafter referred to as MGT) has published on its website (www.gaztranzit.hu) its interruptible daily gas transmission test capacities available to book for gas days for the Balassagyarmat SK>HU cross-border interconnection point, as an entry point and for the Balassagyarmat HU>SK cross-border interconnection point, as an exit point according to the following:

Product:

Offered interruptible daily capacity at Balassagyarmat SK>HU cross-border interconnection point as entry point	163 200 000 MJ/day (NCV)
Offered interruptible daily capacity at Balassagyarmat HU>SK cross-border interconnection point as exit point	6 800 000 MJ/hour (NCV)
Contract period	From 1 st of April 2015 until 30 th of April 2015
Type of transmission capacity	interruptible daily capacity

MGT offers only interruptible transmission capacities during the test period.

Tariff:

The transmission fees will be published on the website of MGT (www.gaztranzit.hu) until 3rd working days before the gas day.

Request and Allocation mechanism:

- The Requestor shall undertake to contract with MGT according to the following:
 - Daily Interruptible Framework Contract – signed no later than 5th working days before the first requested gas day
 - IT Platform Agreement – signed no later than 3rd working days before the first requested gas day

The above mentioned contracts will come into effect as it will be signed by System User and MGT and MGT will send it via e-mail to the System User on the day of signature.

- Requests shall be submitted on the IT Platform of MGT according to the 8.4.2.5 point of the effective Grid Code. The capacities will be allocated according to the 8.4.2.5.d point of the effective Grid Code. In case of overbooking MGT will allocate its above offered capacities to the Requestors at pro-rata based. In case only one requestor submits request and it will be

higher than the above offered capacities, MGT will curtail its request to the above offered level and allocate according that.

3. The Requestor or its contractual partner shall undertake to conclude the required transmission contract with the adjacent System Operators.
4. According to 212/2014 Governmental Decree, no financial obligation and no capacity booking is required at Vecsés connection point, but requestors must have KFSZRI contract with FGSZ for transition to the adjacent FGSZ system.
5. MGT shall require financial guarantee in case of HU>SK delivery direction related to transmission volume fee which shall be the precondition for concluding the contract.
6. Requestor shall be submitted its shipper pair by the adjacent System Operators no later than 5th working days before the first requested gas day. In default of it MGT is not able to accept the nominations.
7. MGT will provide the capacities according to the confirmed quantity on its Informatics Platform.
8. Requests shall be submitted no later than 2. p.m. on the last working day before the gas day to MGT according to the following:

Contract will be binding from MGT in case properly signed contract by MGT being delivered to System User.

This capacity offer shall by no means be deemed as a contractual commitment of MGT towards any Bidder; and MGT explicitly reserves the right to declare the capacity booking procedure as unsuccessful within its own scope of competence. MGT has the right to offer daily interruptible capacities for testing the complete system capabilities. MGT has the right for discontinuation of offering test capacities.
