(a) a person subject to a Sanction imposed by a relevant United States Department or agency (including persons on OFAC's 12 lists of Specially Designated Nationals and Blocked Persons and Foreign Sanctions Evaders), or a legal entity or entities owned fifty percent (50%) or more by one or more such persons; or

(b) persons subject to a financial and property restrictive measure imposed by the European Union (on the EU Consolidated Sanctions List), or (i) legal persons owned or controlled to the extent of fifty percent (50%) or more by one or more such persons, or (ii) acting on behalf or at the direction of such persons; and

(c) a person subject to a financial and property restrictive measure imposed by the UN Security Council;

(d) a person subject to a financial and property restrictive measure imposed by the UK HM Treasury;

(e) a person who is resident, licensed or a national (resident) of a country or territory subject to comprehensive sanctions (including, without limitation, Burma/Myanmar, North Korea, Crimea,

Cuba, Iran, North Korea, Sudan and Syria, and Venezuela, but taking into account changes that may occur over time).
